Standalone PAT increased by 36% to ₹ 58 cr. for Q3 19-20 vs. ₹ 43 cr. in Q3 18-19. Standalone Sales increased by 30% to ₹ 206 cr. for Q3 19-20 vs. ₹ 159 cr. in Q3 18-19.

Consolidated PAT increased by 39% to ₹ 51 cr. for Q3 19-20 vs. ₹ 37 cr. in Q3 18-19. Consolidated Sales increased by 20% to ₹ 288 cr. for Q3 19-20 vs. ₹ 240 cr. in Q3 18-19.
