

## SpiceJet introduces two new flights from Ahmedabad and Surat to Jaisalmer

**GURUGRAM,** India's favourite carrier - SpiceJet - today announced the introduction of two new flights under the regional connectivity scheme, UDAN for the under-served markets of Ahmedabad-Jaisalmer and Surat-Jaisalmer. In its quest to onboard non-metros and smaller cities onto the national aviation map, the airline has also introduced eight new flights from Gujarat.

The airline will launch direct flights on the Ahmedabad-Jaisalmer-Ahmedabad and Surat-Jaisalmer-Surat routes starting October 31st and November 30th respectively. The routes were awarded to the airline under UDAN II. With the introduction of the two aforesaid routes, SpiceJet will operate 25 daily flights under UDAN in straight 14 months since its first launch in July 2017.

SpiceJet announced the launch of five new direct

flights from Ahmedabad including an UDAN flight and three new industry first flights. The airline also announced three direct flights from Surat. SpiceJet will be the first and only airline to operate direct flights on the Ahmedabad-Jabalpur, Ahmedabad-Dehradun, Ahmedabad-Patna and Surat-Udaipur sectors which have a heavy demand from both business and leisure travellers. A daily flight between Varanasi and Surat via Udaipur has also been introduced.

Additionally, SpiceJet is all set to enhance its operations on the Surat-Goa sector with a second direct flight from 30th November. Ahmedabad-Patna flights will operate from 28th October while flights on Ahmedabad-Jabalpur, Ahmedabad-Dehradun and Ahmedabad-Jodhpur sectors will start from 31st October. The first flight services under Surat-Udaipur and Udaipur-Varanasi routes will

start from 30th November. All the new flights introduced will be operational on all days except Sundays whereas the flights on the Ahmedabad-Dehradun-Ahmedabad route will fly daily. While the airline will be deploying its Boeing 737 on the Ahmedabad-Patna route, its fleet of Bombardier Q-400 aircrafts will be engaged on the remnant new routes. Shilpa Bhatia, Chief Sales and Revenue Officer, SpiceJet said, "SpiceJet has been introducing flights on UDAN routes at a great pace. In a span of mere 14 months we have launched 25 flights under UDAN which is a new milestone for us and the Indian aviation and we are proud of this. The new UDAN flights connecting Jaisalmer to Ahmedabad and Surat are a step forward in this direction. The host of new flights from Gujarat will help in enhancing connectivity thereby resulting in a direct boost in trade and economy."

## Business Brief

### NSE tests E-voting solution for listed companies

**Mumbai,** Stock exchange major National Stock Exchange (NSE) has commenced a pilot project to provide a "transparent and low-risk solution for E-Voting" using blockchain technology for listed companies.

The exchange in a statement on Thursday said: "The pilot, which has been conducted, would involve setting up a blockchain to connect the regulator with the company and the RTA (Registrar and Transfer Agents) during the voting process."

"The voting rights will be tokenised, thus making them easy to transfer and proxy. The test will be evaluated on the auditability of the actions on the chain as well as the ease of conducting the process using blockchain."

### Air India's revival plan in process of approval: Minister

**New Delhi,** The revival plan for debt-laden national carrier Air India is going through the government's approval process, an official said on Thursday.

Minister of State for Civil Aviation Jayant Sinha told this to reporters on the sidelines of an event here.

Earlier, the government had invited Expression of Interest (EoI) on March 28 this year for disinvestment of Air India, including the national carrier's share-holding interest in the Air India Express Ltd and Air India SATS. But it received no response till May 31, the closing day. Currently, the airline is in a cash-strapped stage. It has also invited bids from banks for a Rs 500-crore government guarantee-backed "short term loans (STLs)".

### Rising oil prices could climb further: Eni CEO

**Rome,** Current market conditions could drive crude oil prices up "even higher" with "negative" consequences for producers and consumers, said the chief executive of Italy's oil and gas giant Eni, Claudio Descalzi.

"This would be negative for all but market conditions could push prices up even higher," Descalzi told Italian daily Corriere della Sera in an interview. Oil prices eased on Wednesday but were still poised for a fifth consecutive quarter of gains. Crude price rises are being driven by the impending implementation of US sanctions to halt oil exports from Iran and a drop in exports from the major oil producer in the last three months of the year. Asked if crude oil prices could hit 100 dollars a barrel, Descalzi said: "I won't risk making a prediction."

### IL&FS Financial Service defaults on payment obligations

**Mumbai,** IL&FS Financial Service (IFIN) has defaulted in payment obligations of bank loans (including interest), term and short-term deposits. According to a BSE filing, the bank loan (including interest) obligations were worth Rs 284.5 crore. As per the filing, the obligations on term deposit were Rs 103.53 crore and short-term deposit were worth Rs 52.43 crore. The firm is a Non-Banking Finance Company (NBFC) which provides a range of financial and advisory solutions. It specialises in infrastructure financing transactions, among other things.

### RBI likely to hike repo rate by 25 bps: SBI report

**Mumbai,** The Reserve Bank of India (RBI) is expected to hike its key lending rate by 25 basis points in October, a SBI Ecowrap report said on Thursday. According to the report, the expected rate hike might not be the last one in the current fiscal. In August, the RBI had hiked its key lending rate by 25 basis points to bring the repo to 6.50 per cent citing upside risks to inflation.

### Equity indices in red as auto, metal stocks slump

**Mumbai,** Amid volatility, the key Indian equity indices traded on a negative note on Friday afternoon. Although firm global cues lifted the indices earlier in the day, heavy selling pressure in auto and metal counters depressed the market around 1.50 p.m. Index-wise, the NSE Nifty50 traded at 10,980 points (1.54 p.m.), lower by 2.45 points or 0.02 per cent from the previous close. The BSE Sensex, which had opened at 36,452.74 points, traded at 36,272.91 points, down 51.26 points or 0.14 per cent from the previous close of 36,324.17 points. So far, it has touched an intra-day high of 36,551.86 points and a low of 36,208.01.

## SBI expects 53% recovery from first list of 12 stressed accounts

**Kolkata,** The SBI, which has introduced an "intermediary credit review mechanism", is expecting a recovery of around 53 per cent of its exposure in the RBI's first list of 12 stressed accounts, referred to NCLT for corporate insolvency resolution, an official said on Friday.

"In the 12 cases (of the first list of Reserve Bank of India) referred to the National Company Law Tribunal (NCLT), we are expecting a recovery of about 53 per cent and the hair-cut will be not more than 47 per cent."

"We have made adequate provisions for this and it will not impact the balance sheet. Our average provisioning for these cases will be around 55 per cent," State Bank of India (SBI) Managing Director Dinesh Kumar Khara said.

He said that the lender would be able to make adequate provisions for the second list of stressed accounts by the time these cases are heard in the NCLT.

"We have 75 per cent provisions already in place (for the stressed accounts) in the second list. By the time they are heard, we are confident to make 100 per

cent provisions," Khara said.

The lender brought in an "intermediary credit review mechanism" which critically reviews credit proposals, he said. "We have come out with new department, which is known as credit review department comprising specialists who evaluate each and every proposal. Based on their assessment, they give a decision in terms of go or no-go. It was set up about two months back," he said on the sidelines of the Banking Colloquium organised by CII. He said that the SBI has an elaborate risk review mechanism.

The state-run lender is looking at 10 per cent credit growth and 15 per cent deposit growth for the current fiscal, he said, adding that corporate lending constitutes about 40 per cent of the total portfolio.

## Nation-wide traders strike against Flipkart-Walmart deal

**New Delhi,** Amid a nation-wide traders' strike on Friday called by the Confederation of All India Traders (CAIT), the organisation submitted a memorandum to Prime Minister Narendra Modi.

In response to the call for a "Bharat Trade Bandh" against the Walmart-Flipkart deal and foreign direct investment in retail, the commercial markets across the country were closed on Friday, a CAIT statement said.

The traders body submitted the memorandum and a Traders Charter to Modi urging for his intervention to stop the deal as it violates FDI Policy Press Note Number 3 of 2016 of the government, CAIT Secretary General Praveen Khandelwal said in a statement.

It urged Modi to constitute a high level committee under the chairmanship of a senior Union Minister and comprising officials and trade representatives to look into the matter.

On Friday around seven crore business establishments and more than 40,000 trade associations and federations across the nation participated in the one-day strike, the traders' organisation said.

Traders across the country held "dharna", demonstrations and protest marches and later submitted similar memorandum as given to the Prime Minister to their respective District Collectors, CAIT said.

The CAIT also regretted that retail trade has never been a priority although after agriculture, it is the largest employment provider and largest source of revenue for the government.

"Such a stepmotherly treatment to the traders must come to an end," the statement said.

On August 28, the Confederation had approached the National Company Law Appellate Tribunal (NCLAT) against the Competition Commission of India (CCI)'s approval for the Walmart-Flipkart deal.

Consequently, NCLAT issued a notice to Walmart, enquiring about its business model. In August, Walmart Inc acquired approximately 77 per cent stake in e-commerce major Flipkart.

Walmart now holds approximately 77 per cent of Flipkart, while the remainder of the business is held by other shareholders, including Flipkart co-founder Binny Bansal, Tencent, Tiger Global and Microsoft Corp.

The global retail giant's investment includes \$2 billion of new equity funding to help accelerate the growth of Flipkart's business. Both companies will retain their unique brands and operating structures in India, the statement said.
